



**REGION I EVENTS POLICY**  
**REFEREES/ASSESSORS and HEAD OF DELEGATES**  
**2015 PROPOSAL**

State Associations with teams entered in the Region I Presidents Cup, ODP Tournament and the Region I Championships **MUST** identify the required amount of Referees & Assessors listed below.

If a State Association cannot send the required number of referees and or assessor that State Association will have to pay the following (per referee and or assessor) to the State Association that sends the replacement(s): (1) Event Stipend; (2) Travel Expenses to/from the event and (3) include the replacement referee and or assessor in dinner plans on the night each State Association takes officials to dinner. The Region I Referee Administrator will solicit replacement referees and or assessor from either the Host State or other states in Region I.

If a State Association has a **NO-SHOW** for a Region I Event they will be **FINED** \$500.00 and payment will be due in the Region I Office two (2) weeks after completion of the event.

It is the responsibility of each State Association sending Referees and Assessors to identify one individual (of the attending group of referees and assessors) as Head Delegate, whose responsibility will be that of overseeing the conduct of his/her State Association's Referees and Assessors attending the event. Identification of said delegate will be made on the Referee/Assessor Roster Form. ***If a State Association chooses to select a HOD that is not part of their delegation they will be billed for lodging and meals.***
